## 7) How would you proceed on the issue of school start times?

I think the first step is allowing students to take online courses in place of a period or two during the day. Students can then choose to come in later in the morning if they wish. As money becomes more available we need to continue to find a way to compress the entire bell schedule so that all schools can open between 8:00 and 9:15 in the AM and dismiss between 3:00 and 3:45 PM. If we can find a no cost solution that the community can agree to, that would be the best solution of all. In the last few years, many of the cost saving efficiencies suggested by the Transportation Task Force were adopted. The savings helped save classroom positions but were not used to buy more buses needed to compress the bell schedule. The recession called for tough decisions. Going forward, many areas of change would help relieve the need and thus cost of school transportation such as more safe walking paths and more public transportation. The FCPS bus routes must be as efficient as possible. The new GPS systems on buses have created valuable efficiencies. The constant look for more efficiencies must continue.

Students and parents need to find a realistic balance of school and community activities so that students are not so overscheduled and do not take on unrealistic class loads. Parents and students often find themselves caught between trying to prepare the best college admissions resume while trying to adopt a healthy lifestyle that includes enough sleep and downtime. Our high schools tell students and families that the choice of a college should be based on the best fit for what the student is interested it. However if the parents and students are trying to gain admission to one of the highly selective instate or private colleges/universities, there is often a commitment to take on an extremely heavy load of classes and extracurricular activities. The competition to get into these schools is fierce and there are many, many very well qualified students applying, including large numbers from FCPS. Counselors tell students and families there is a place in college for all who want to attend, but caution students to be resilient if their top choice rejects them.
